

Specifications

It is the intent of these specs to provide for the purchase of a new electric powered, eternally rechargeable 4 door sedan with internal gas powered recharge motor, such as the 2012 Chevy Volt, or equal.

This spec is not to be interpreted as restrictive but rather as a measure of the standards which all other electric vehicles shall be measured. It is the intent of these specifications to describe a Chevy Volt or equal, electric vehicle in sufficient detail to assure that that product reliability, design integrity, technical soundness and performance are provided.

The unit provided shall be new and the manufacturer's current production model and shall be built no earlier than the 2012 model year.

The bidder shall have qualified personnel to train any Town personnel in the safe handling, operation and maintenance of the vehicle.

Bidder must be a factory authorized dealer and service facility for the vehicle specified. Bidder must be able to respond to a service call within 60 minutes.

Note: The Town has become aware that there is a tax rebate available through the IRS to the seller on this vehicle and expects that the bid price should reflect that rebate.

At years end, the Town will support any allowable disclosure documents required by the seller to recoup said rebate.
